

In recognition of its commitment to quality education, the College is fully funded by the University Grants Commission (UGC) and has been maintained by the University of Delhi since 1972. Later, in 2010, it was renamed Ramanujan College, and within two years, it transitioned into a full-fledged day college, marking a new chapter of academic and institutional transformation.


1.4 ORGANISATIONAL STRUCTURE

DEPARTMENT OF POLITICAL SCIENCE

The Department of Political Science is one of the oldest departments of the College. It was established in 1958 when the college began as Deshbandhu (Evening College), offering Political Science papers to B. A. (Pass) students. The Department began to offer an Honours course in Political Science in 1969. Since the College was renamed Ramanujan College in 2010 and became a full-fledged morning college, the Department got the scope to expand its sphere of activities on a larger scale. Various programmes to engage the students and enhance their creativity and skills have been introduced, along with innovative methods of teaching. Through their active engagement, students are empowered to face real-world challenges with confidence, courage, and competence, contributing meaningfully to society.

PLACEMENT AND CAREER DEVELOPMENT CELL

This Cell provides career guidance and placement assistance to the students. It interacts with the industry and showcases the academic achievement of the students. It also focuses on enhancing the employable skills of the students through programmes on Personality Development, Interpersonal Communication, and Resume writing. It also invites leading industrialists and professionals, organises lectures, workshops, talks, seminars, and training programmes across disciplines. Over the years, there has been impressive recruitment of students in various industrial sectors like Concentrix, Genpact, Data Flow, Naukri.Com, ICICI Prudential, Talocity, Tata Consultancy Services, Bajaj Finance, Ernst & Young. The efforts of the Placement Cell have also been fruitfully in placing the students with different lucrative summer internships.

With regard to the Career Development of our students, our placement cell has collaborated with many esteemed organisations to provide short-term courses with proper certifications open to all the students some of which include the Business Analyst course by Microsoft, Stock Market Models by BSE, etc. and classes for CAT preparation. The placement cell also organizes its flagship event "AARAMBH" the annual job and internship fair every year.

CII YI YUVA CHAPTER

The Confederation of Indian Industry (CII) plays a pivotal role in shaping a vibrant and growth-oriented industrial environment in India. As an integral part of CII, Young Indians (Yi) is a dynamic movement of young professionals, entrepreneurs, and achievers aged between 21 and 40 years. Yi functions with the core objectives of Youth Leadership, Nation Building, and Thought Leadership, offering a platform for young Indians to contribute meaningfully towards building a developed and inclusive nation.

Yuva, the student wing of Yi, connects and engages youth from academic institutions across the country in various nation building initiatives. Yi currently partners with 86 institutions and over 8,500 students through its expansive Yuva network. Extending this initiative, the CII YI YUVA CHAPTER was established at the college in 2018. PANDIT DEENDAYAL UPADHYAYA RESEARCH DEVELOPMENT AND SERVICE CENTRE (PDU-RDSC)

Established in 2017 with the vision to "Transform. Innovate. Collaborate.", the PDU-RDSC has been a catalyst for academic innovation, digital transformation, and impactful research at Ramanujan College. The Centre promotes in-house project development, technological advancement, and capacity building to enhance the institution's academic ecosystem.

In 2024–25, the Centre expanded its research landscape by establishing three state-of-the-art laboratories inaugurated by Prof. Yogesh Singh, Vice Chancellor, University of Delhi:

- 5G & Next-Generation Connectivity Lab: Supports research on 5G, wireless networks, and edge computing.
- AR/VR Lab: Facilitates immersive technology projects in education, healthcare, and training.

 Soil Testing Lab: Advances precision agriculture through real-time soil analysis using the Pusa STRF meter.

The Centre plays a key role in maintaining the College's digital infrastructure, managing platforms such as:

- remoocs.in (MOOCs), rijbr.in (Research Journal), moocshub.com, recon.in, and ijaethics.in.
- Koha Library System and DSpace Repository.
- NAAC & NBA Portals for compliance and accreditation

The Centre's first consultancy project, Automation of Ballot Counting for SBI Officers' Election, earned ₹3,00,000 and set the tone for future collaborations. It later partnered with Reliable Data Pvt. Ltd. for a successful technical project. During the COVID-19 lockdown, PDU-RDSC developed an inhouse Learning Management System (LMS) ensuring academic continuity through interactive online learning.

The Centre has trained over 1.5 lakh educators nationwide through Faculty Enrichment Programmes in collaboration with the Teaching Learning Centre (TLC). It also supports short term student courses aligned with the National Education Policy (NEP) 2020, fostering industry-ready skills and holistic learning. Through its multifaceted initiatives, PDU-RDSC continues to transform Ramanujan College into a hub of research, innovation, and digital excellence.

MALAVIYA MISSION TEACHER TRAINING CENTRE (MMTTC)

The Ministry of Education (MoE), formerly known as the Ministry of Human Resource Development (MHRD), launched the Pandit Madan Mohan Malaviya National Mission on Teachers and Teaching (PMMMNMTT) to enhance the quality of teacher training across India. As part of this initiative, Malaviya Mission Teacher Training Centres (MMTTCs) were established in select higher education institutions. Within the University of Delhi, only two institutions were granted this prestigious opportunity—Ramanujan College being one of them.

The MMTTC at Ramanujan College was established with the objective of "Reaching the Unreached", targeting educators from diverse regions and remote areas of the country. Since its inception in October 2017, the Centre has successfully conducted over 100 learner-centric programmes, training more than 1.5 lakh teachers from across India in a wide array of discipline-specific and interdisciplinary areas.

MMTTC programmes feature distinguished and internationally recognized experts who deliver lectures and conduct interactive sessions on contemporary and globally relevant topics. These sessions are also made available on the official YouTube channel of Ramanujan College to benefit a broader

audience. Ramanujan College has been a pioneer in offering both offline and online faculty development programmes, utilizing a custom-built Learning Management System (LMS) developed by its Research Development and Services Cell (RDSC). This LMS ensures an enriching, accessible, and structured learning experience for faculty members and research scholars from institutions nationwide

2.2 STRUCTURE OF UNDERGRADUATE PROGRAMMES UNDER NATIONAL EDUCATION POLICY (NEP)

(Ref- CNC-II/093/1(20)/2021-22/192)

2.2.1 DEFINITIONS

i. Academic Credit: An academic credit is a unit by which the course work is measured. It determines the number of hours of instructions required per week. One credit is equivalent to one hour of teaching (lecture or tutorial) or two hours of practical work/field work per week.

- ii. Courses of Study: Courses of the study indicate pursuance of study in a particular discipline. Every discipline shall offer three categories of courses of study, viz. Discipline Specific Core courses, Discipline Specific Electives and Generic Electives.
- a. Discipline Specific Core (DSC): This is a course of study, which should be pursued by a student as a mandatory requirement of his/her programme of study. DSCs shall be the core credit courses of that particular discipline which will be appropriately graded and arranged across the semesters of study, being undertaken by the student, with multiple exit options as per NEP 2020. The DSCs specified in the framework would be identified by the concerned Department as core courses to be taught in a Programme.
- **b. Discipline Specific Elective (DSE):** The Discipline Specific Electives (DSEs) shall be a pool of credit courses of that particular discipline (single discipline programme of study) or those disciplines (multidisciplinary programme of study), as the case may be, which a student chooses to study from his/her particular discipline(s). There shall be a pool of DSEs from which a student may choose a course of study. The DSEs specified in the framework would be identified by the concerned Department as elective courses to be taught in a Programme.
- c. Generic Elective (GE): Generic Electives shall be a pool of courses which is meant to provide multidisciplinary or interdisciplinary education to students. GEs shall consist of a pool of courses offered by various disciplines of study (excluding the GEs offered by the parent discipline), in groups of odd and even semesters, from which a student can choose. The GEs specified in the framework would be identified by the concerned Department as GEs to be taught in a Programme. In case a student opts for DSEs beyond his/her discipline specific course(s) of study, such DSEs shall be treated as GEs for that student.
- d. Ability Enhancement Course (AEC), Skill Enhancement Course (SEC) and Value Added Course (VAC): These three courses shall be a pool of courses offered by all the Departments in groups of odd and even semesters from which students can choose. A student who desires to make Academic Project/Entrepreneurship as Minor has to pick the appropriate combination of courses of GE, SEC, VAC, & Internship/Apprenticeship/Project/ Community (IAPC) which shall be offered in the form of various modules as specified in the scheme of studies. AEC courses are the courses based upon the content that leads to knowledge enhancement through various areas of study. They are Language and Literature and Environmental Science and Sustainable Development which will be mandatory for all disciplines. SEC are skill-based courses in all disciplines and are aimed at providing hands-on training, competencies, proficiency and skills to students. SEC courses may be chosen from a pool of courses designed to provide

skill-based instruction. Every discipline may provide skill based courses, some of which may be offered to students of its discipline while the rest can be

open to students of all other disciplines. *VAC* courses are common pool of courses offered by different disciplines and aimed towards personality building; embedding ethical, cultural and constitutional values; promote critical thinking, Indian Knowledge Systems, scientific temperament, communication skills, creative writing, presentation skills, sports & physical education and team work which will help in all round development of students.

iii. Major Discipline:

(a) A student pursuing undergraduate programme in a specific discipline (Core course) shall be awarded an appropriate Honours degree with Major in a Discipline on completion of VIII Semester, if he/she secures in that Discipline at least 50% of the total credits i.e., at least 88 credits in that Discipline out of the total of 176 credits. He/she shall study 20 DSCs and at least 2 DSEs in eight semesters. For instance, a student who pursues B.Com. (Honours) shall earn the minimum 88 credits from 20 DSCs and at least two DSEs in order to get Major in Commerce.

OR

- (b) A student pursuing undergraduate programme in more than one discipline as Core Course (for example B.A. Social Sciences/ Humanities, B.Sc. Life Sciences, B.Sc. Physical Sciences, B.Sc. Mathematical Sciences, B.Com. and such other programmes) shall be awarded appropriate Honours degree with Major in a Discipline on completion of VIII Semester, if he/she secures in that Discipline 80 credits out of a total of 176 credits. He/she shall study 6 DSCs and at least 3 DSEs in that discipline in the first six semesters and 2 DSCs, 6 DSEs and write dissertation in that discipline in the VII and VIII semesters. For instance, a student who pursues B.A. (Honours) Social Sciences/Humanities shall be eligible for Major in History, on completion of VIII semester, if he/she earns minimum 80 credits from 8 DSCs and at least 9 DSEs of History and writes dissertation on a topic related to History.
- iv. Minimum Acceptable Level of academic standards: The minimum acceptable level of achievement that a student must demonstrate to be eligible for the award of academic credit or a qualification is the minimum acceptable level of academic standards. The Letter Grades and Grade Points which shall be used to reflect the outcome of assessment process of the student's performance is indicated in the below Table.

v. Minor Discipline: A student mentioned at iii (a) above may be awarded Minor in a discipline, on completion of VIII Semester, if he/she earns minimum 28 credits from seven GE courses of that discipline.

OR

A student mentioned at iii (b) above may be awarded Minor in a discipline, on completion of VIII Semester, if he/she earns minimum 28 credits from six DSCs and one DSE of that discipline. This definition of Minor is independent of GEs for which there is a requirement of 28 credits to be treated as Minor. The concept of Minor is relevant only when there is a Major discipline.

2.2.2. OBJECTIVES

The Undergraduate Curriculum Framework- 2022 (UGCF) is meant to bring about systemic change in the higher education system in the University and align itself with the National Education Policy 2020. The following objectives of NEP are kept in perspective while framing UGCF:

- to promote holistic development of students having the world view of a truly global citizen;
- to provide flexibility to students so that learners have the ability to choose their learning trajectories and programmes, and thereby choose their paths in life according to their talents and interests;
- to eliminate harmful hierarchies among disciplines/fields of study and silos between different areas of learning;
- multi-disciplinarity and holistic education to ensure the unity and integrity of all knowledge;
- to promote creativity and critical thinking and to encourage logical decision-making and innovation;
- to promote ethics and human & Constitutional values;

- to promote multilingualism and the power of language in learning and teaching;
- to impart life skills such as communication, cooperation, teamwork, and resilience;
- to promote outstanding research as a co-requisite for outstanding education and development;
- to incorporate Indian Knowledge System relevant for a particular discipline or field of studies.

2.2.3. FEATURES

The aforementioned objectives of the NEP have been reflected in various features of UGCF:

- Holistic development of the students shall be nurtured through imparting life skills in initial years.
 These life skill courses shall include courses on 'Environment and Sustainable Development
 Studies', 'Communication Skills', 'Ethics and Culture', 'Science and Society', 'Computational
 Skills', 'IT & Data Analytics', and similar such skills which shall make the students better
 equipped to deal with the life's challenges.
- Flexibility to the students to determine their learning trajectories and pursuance of programmes of study has been well ingrained in the UGCF. The Framework allows students to opt for one, two, or more discipline(s) of study as a core discipline(s) depending on his/her choice. He/she has been provided the option of focusing on studying allied courses of his/her selected discipline(s) (DSEs) or diversifying in other areas of study of other disciplines. Students have also been provided with the flexibility to study SECs or opt for Internships or Apprenticeship or Projects or Research or Community Outreach at an appropriate stage. In the fourth year, students are provided flexibility to opt for writing a dissertation (on major, minor, or combination of the two) or opt for Academic Projects or Entrepreneurship depending upon their choice and their future outlook, post completion of their formal education.
- Given the extent of plurality of the Indian society and the diverse background to which students belong, multiple exits and provision of re-entry have been provided at various stages of the undergraduate programme to accommodate their requirement and facilitate them to complete their studies depending upon their priorities of life. The earning and accumulation of credits in the Academic Bank of Credit (ABC), and the flexibility to redeem the requisite credit for award of appropriate Certificate/Diploma/ Degree, as the per the norms laid down by the UGC and the University, shall be made available to the students to provide the opportunity for lifelong learning as well as for availing academic outreach beyond the superstructure of the programme of study in another University/Institution at the national /international level depending upon individual choice of the student(s).

- UGCF has incorporated multidisciplinary education by embedding within the framework the need to opt for at least four elective papers from any other discipline(s) other than the one opted as core discipline(s). In fact, a student who pursues a single-core discipline programme may obtain minor in a particular discipline, other than the core discipline, if he/she earns at least 28 credits in that particular discipline.
- The framework does not maintain/support hierarchy among fields of study/disciplines and silos between different areas of learning. As long as a student fulfils the pre-requisites of a course of study, he/she shall be able to study it. Modules or systems of study shall be meaningfully laid down so as to guide the students in choosing the track/academic paths for the desired outcome.
- One of the significant hallmarks of the framework is a provision of pursuing multilingualism while studying any other discipline as core subject(s), which has no bearing with any language and linguistics. I and II semesters of the programme provides an opportunity to the students to study languages which are enshrined under the eighth schedule of the Constitution of India, thereby allowing the students for their holistic development, including the ability to acquire proficiency in a language beyond their mother tongue.
- The framework provides a mandatory programme on research methodologies as one of the discipline specific elective (DSE) courses at the VI & VII semester for students who opt for writing dissertation on major/ minor at VII and VIII semesters. Further, provision for internship / apprenticeship/ project/ community outreach right from the III semester up to VI semester provides ample opportunity to the students to explore areas of knowledge / activity beyond the four walls of the classroom and reach out to the world outside without any dilution of the academic feature of the course of study, he/she is pursuing. This also acts a precursor for the students to take up academic project or entrepreneurship at a later stage in VII & VIII semester. Such an initiative will help in skill development and laying a strong foundation for research and thus contribute towards overall national development through the development of skilled manpower and innovation.
- Intra and inter-University mobility of students is another element of critical importance which has been ingrained in the framework. A student, by virtue of such mobility, will be able to make lateral movement within the University as well as from the University to any other Institution and vice-versa. Such an attribute allows a student maximum flexibility in terms of pursuance of education with special reference to higher education and enables him/her to achieve goal of life, the way he/she perceived it.

2.2.4. QUALIFICATION TYPES AND CREDIT REQUIREMENTS

Qualifications are formal 'awards' such as a certificate, diploma or a degree are awarded by a competent authority such as a college or university in recognition of the attainment by students of the expected learning outcomes on the successful completion of a particular programme of study. They are awarded after an assessment and evaluation of learning levels conducted by a competent body that determines the achievement by students of the expected learning outcomes to given standards.

A student who exits at the end of any even semesters has to earn the requisite credits in order to be awarded the relevant certificate/diploma/degree. The qualification title/nomenclature and corresponding Credits Requirements (CR) relevant for Level 4.5 to Level 6 of the UG programmes are:

(i) Re- Entry

Re-entry refers to the process of entry into the next level of study by a student already enrolled in a programme of study of the university or its college, who exited after completion of the preceding level of study.

(ii) Re- Entry allowed in the same college and same programme

- 1. Students are allowed re-entry into the same programme of study in which he/she has been enrolled, after exiting in between the four year undergraduate programme.
- 2. Credits earned shall be valid for redemption for a maximum duration of 7 years.

- 3. Students enrolled in a programme of the University of Delhi and its Colleges, who exit in between a programme shall be allowed to re-enter in the same College and the same programme of the relevant semester.
- 4. Power to remove difficulties- in case of any differences or dispute in the interoretation or implementation of these guidelines, the decision of the Vice Chancellor, University of Delhi Shall be final and binding.

Note- A student who avails multiple exits in course of his/her studies in a particular programme shall have to ensure that credits earned in the first year remains valid till the end of the tenure of the programme schedule i.e., 2 years for undergraduate diploma, 03 years for bachelor degree/hons. Degree and 4 years for bachelor hons. Degree/hons. with research/hons. With entrepreneurship, taking into consideration the validity of credit for a maximum period of 07 years the credits id earned.

However, a student pursuing multidisciplinary studies in three core disciplines shall have to choose research methodology in VI semester, if she/he wishes to Major in one of the three disciplines in the fourth year.

Suppose a student wishes to study the Research Methodology course offered by another discipline (as one of its DSEs). In that case, he/she may opt for it provided such discipline is his minor discipline. The Research Methodology of another discipline so opted shall be treated as GE for him/her.

On the occasion of Sports Day, the students excelling in the field of sports are conferred with trophies and awards. There is also a provision of Best Athlete in the category of Boys and Girls. Additionally, fee concessions are available for outstanding **meritorious students** based on excellence in academics, sports, extracurricular activities, or financial need, as determined by the Fee Concession Committee.

4.3 ANTI-RAGGING MEASURES

The Proctorial Committee actively undertakes all precautionary and preventive measures to ensure a ragging-free environment on campus. It diligently enforces the UGC regulations for curbing the menace of ragging in higher educational institutions, in line with the directives of the Hon'ble Supreme Court of India.

The names, telephone numbers, and email addresses of all Proctorial Committee members are prominently displayed at strategic locations across the College and on the official College website. To facilitate anonymous reporting, complaint boxes are installed at easily accessible and visible spots throughout the campus. A robust surveillance system, comprising CCTV cameras and the vigilant presence of male and female security personnel, along with regular monitoring by teaching and non-teaching staff on the Principal's instructions, contributes to maintaining a zero tolerance policy towards ragging.

Strict disciplinary actions, including suspension, expulsion, cancellation of degree, or legal proceedings, are taken against any instance of ragging. Through these proactive efforts, the College continues to remain a safe and respectful space for all students.

4.5 STUDENTS' UNION

To facilitate the drafting of the Constitution of the Students' Union—its name, objectives, and structure—an association shall be constituted under the title "The Students' Union, Ramanujan College." The Union aims to promote social and intellectual engagement among students, nurture their skills in expression and public speaking, and provide practical training in the principles and functioning of democratic and parliamentary systems.

5. POLICIES AND REGULATIONS

5.1 DISCIPLINARY GUIDELINES

MAINTENANCE OF DISCIPLINE AMONG STUDENTS

- 1. All powers relating to discipline and disciplinary action are vested in the Principal.
- 2. The Principal may delegate all or such powers as he / she deems proper to the Discipline Committee and to such other persons as he/she may specify in this behalf.
- 3. Without prejudice to the generality of power to enforce discipline, the following shall amount to acts of gross indiscipline:
 - Physical assault, or threat to use physical force, against any member of the teaching and nonteaching staff of the College
 - Carrying of, use of or threat to use of any weapons
 - Any violation of the provisions of the Civil Rights Protection Act, 1976
 - Violation of the status, dignity and honour of students belonging to the scheduled castes and tribes
 - Any practice-whether verbal or otherwise-derogatory of women
 - Any attempt at bribing or corruption in any manner
 - Wilful destruction of institutional property
 - Creating ill-will or intolerance on religious or communal grounds
 - Causing disruption in any manner of the academic functioning of the College and University
 - Ragging
- 4. Without prejudice to the generality of his / her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate, the Principal may in the exercise of his / her powers aforesaid order or direct that any student or students-
 - be expelled; or
 - be, for a stated period rusticated; or
 - be not for a stated period, admitted to a programme or programmes of study in a College, department or Institution of the University; or
 - be fined with a sum of rupees that may be specified; or

- be debarred from taking a University or College Examination or Examinations for one or more years; or that the result of the student or students concerned in the Examination or Examinations in which he/she or they have appeared be cancelled.
- 5. These rules may be supplemented, where necessary, by the Principal of College. Each student shall be expected to provide himself/herself with a copy of these rules. At the time of admission, every student shall be required to sign a declaration that on admission he/she submits himself/herself to the disciplinary jurisdiction of the Principal and College Administration.

ANTI-SMOKING

Smoking is banned in the College in accordance with the Delhi University's Anti- Smoking initiative in partnership with the Delhi Police and the World Lung Foundation – South Asia.

IDENTITY CARD

Identity Cards are issued to all the students of the College. The students should ensure that the particulars in the Identity Card filled by him/her are correct. They are required to produce the Identity Card whenever demanded by any authority of the College.

The Identity Card needs to be renewed every year. The new Identity Card is issued only on the submission of the earlier Card.

ATTENDANCE

All classes will commence from 01 August, 2025. Attendance will be marked from this day.

- 1. The students are required to attend at least 66.6% of all the lectures/tutorials/practical.
- 2. No student shall be allowed to take the university examination unless he/she has fulfilled the minimum attendance requirement of the University.
- 3. In case of illness, a student must inform the College office and submit a medical certificate within a week of his/her re-joining.
- 4. If the medical certificate is not submitted in the above-mentioned period, no benefit in attendance will be given.
- 5. Attendance benefit will be granted to students undergoing internships, as outlined in the Internship Policy (section 5.5).

- 5. The students participating in co-curricular activities/sports etc. should apply in writing, giving the specific dates of participation in such activities, after getting the necessary recommendation on the application, from the concerned teacher.
- 6. The students are required to check their attendance records uploaded on the College website every month.

5.2 ANTI-RAGGING AND ANTI-HARASSMENT POLICIES

College has a no tolerance policy towards ragging and any kind of harassment.

ANTI - RAGGING

Ragging means any act, conduct or practice by which the dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students. It includes individual or collective acts or practices which,

- a) involve physical assault or threat, and/or use of physical force,
- b) violate the status, dignity and honour of women students and the students belonging to the scheduled castes and tribes,
- c) expose students to ridicule and contempt and affect their self-esteem;
- d) entail verbal abuse and aggression, indecent gestures, and obscene behaviour. Ragging in any form is strictly prohibited both within the College premises or any other part of the University of Delhi as well as on public transport. The directives of the University of Delhi, its Acts, Ordinances, and the Guidance of the relevant order of the Supreme Court of India will be strictly adhered to, in all matters related to ragging.

Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt as per Ordinance XV- C of the University.

In case any student(s), who have obtained degrees of the University of Delhi, are found under this Ordinance committing an act or practice of ragging, he/she/they may be subjected under Ordinance XV to appropriate action for withdrawal of degree conferred by the University. For the purpose of Ordinance XV, abetment of ragging will also amount to ragging. The College has set up an Anti-Ragging Committee to redress the complaints related to ragging.

PREVENTION OF SEXUAL HARASSMENT

Sexual Harassment includes any one or more of the following unwelcome acts or behaviour (whether directly or by implication) namely:

a) physical contact and advances; or

b) a demand or request for sexual favours; or

c) making sexually coloured remarks; or

d) showing pornography; or

e) any other unwelcome physical, verbal or non-verbal conduct of sexual nature.

Till 2014, the College had an ordinance in accordance with the University Ordinance XV-D for sexual harassment. Since January 2014, this Ordinance has been superseded by the 'Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act 2013'. This Act seeks to maintain and create an academic and work environment free of sexual harassment for the students, academic and non-teaching staff of the University of Delhi. The Act will also apply to outsiders on the College campus.

5.3 PROMINENT ENVIRONMENTAL POLICIES

POLICY TITLE: Environmentally Sustainable Green Campus.

POLICY NUMBER: RC/IQAC/ESGC/2017

The need for protection and conservation of environment cannot be exaggerated. The Government of India has enacted through legislation and notification many laws, rules and regulations pertaining to sustenance of the environment. Institutionally, there is a need to view the issues of environment and ecology in a holistic manner. Ramanujan College is situated in a highly congested area of South Delhi, surrounded on three sides by residential complexes, with high levels of pollution and chronic lack of water resources. Since the demarcation of the Ramanujan College campus, it has been a paramount concern that the college campus be environmentally sustainable, clean and green. Joining in the mass cleanliness campaign of the Government of India, the Swachh Bharat Abhiyan, this policy pledges the commitment of the College to ecological wellbeing and environmental protection and sustainability.

POLICY STATEMENT

Ramanujan College is dedicated to protect and enrich the ecology of the campus through water conservation, proper waste management systems, eco-friendly practices, thoughtful landscaping, sensitisation and awareness regarding social responsibility and perception towards the environment and undertaking audit procedures.

Policy Purpose and Objective

- To sensitize the students, teaching and non-teaching staff of the College about the importance of environmental protection and encourage them to maintain a clean and green campus.
- To reduce, recycle and reuse.
- To make the campus smoke and plastic free.
- To ensure judicious use of all resources and save for future generations
- To work with all the stakeholders and local community to raise awareness related to environmental problems, ways of addressing them and motivate to adopt environmentally friendly practices.
- To undertake auditing procedures to assess environmental performance and adopt strategies for improvement.

- Organise competitions (poster making, slogan writing, essay/creative writing, poetry, street play)
 on pressing environmental concerns.

- Undertake activities under 'Swachh Bharat Abhiyan' by environment society.
- NSS and NCC of the College.

Audits

- Energy Audit: The College will regularly conduct Energy Audit to review its energy consumption, identify wastage of energy and take measures to reduce carbon footprint.
- Green Audit: The College will regularly conduct Green Audit to examine the environmental conditions in the campus, ascertain that the rules and regulations are being followed and better maintain sustainability of the institution.
- Environment Audit: The College will regularly undertake Environmental Audit to assess the College's environmental performance and take measures to improve the same.

PROCESS AND PROCEDURE

- 1. A detailed action plan will be drawn to implement the areas identified in the policy
- 2. Circulars and notifications will be issued, wherever required.
- 3. Display posters and signages in the campus for awareness and implementation.
- 4. External agencies may be engaged, wherever necessary, through formal MoUs for waste management, recycling and other requirements for environmental sustainability.
- 5. Various plantation drives and collection drives will be evenly integrated in the academic calendar for their smooth handing over to the external agencies, wherever involved.

The Department of Environmental Studies will take the lead in implementation of this policy and conducting the audits.

*The policy is subject to periodic review.

5.4 FITNESS POLICY FOR TEACHING AND ADMINISTRATIVE STAFF

The objective of this policy is to promote physical well-being, reduce stress, improve productivity, and create a healthier work environment for the teaching and administrative staff by encouraging regular physical activity through structured incentives and access to college sports and fitness infrastructure.

Staff members are encouraged to make use of the following on-campus facilities during designated hours: Gymnasium, Sports ground, Badminton court, Volleyball court, Table tennis room.

KEY INITIATIVES

- Facility access and use
 - -Reserved time slots for staff usage of gym and indoor sports area.
 - -Open access to outdoor ground and volleyball court during non-instructional hours.
- Group Fitness Programs
 - -weekly yoga and stretching sessions for all the staff.
 - -Monthly inter-departmental friendly matches in badminton, volleyball or table tennis.
 - -Guided morning/evening walking and jogging groups.
- Health educations and support
 - -Quarterly wellness talks on topics such as mental health, nutrition and ergonomics.
 - -Annual health check-up camps organized in partnership with recognized hospitals.

INCENTIVES AND RECOGNITION

- Quarterly incentives
 - -Team fitness challenge winners will receive departmental recognition and team lunch vouchers.
 - -"Most Improved Participant" award based on wellness milestones.
- Annual recognition
 - -"Fitness Ambassador" title will be awarded to the top consistent participant across the year on the basis of measurable parameter during annual staff gathering.

GUIDELINES FOR PARTICIPATION

- -Participation is voluntary and open to all staff irrespective of age or fitness level.
- -Medical clearance is recommended for individuals with health concerns.
- -Participants must wear appropriate sportswear and maintain facility decorum.
- -Equipment must be used responsibly and kept in good condition.

5.5 RAMANUJAN COLLEGE INTERNSHIP POLICY

Ramanujan College is dedicated to promoting practical learning experiences for students through internships and apprenticeships that complement their academic education. This document outlines the official policy regarding attendance for students participating in internships/apprenticeships from the academic year 2024-25. The policy applies to internships/apprenticeships acquired either through the College's Placement and Career Development Cell or through individual student initiatives.

1. ELIGIBILITY GUIDELINES

- a) Eligible Students: Only Bonafide students currently enrolled in semesters III/IV/V/VI/VII/VIII are eligible for attendance benefits associated with internships.
- **b) Duration Limit:** Attendance benefits will be granted only for the duration of the internship, with a maximum duration of 2 months per semester for Semester III and IV students, and 3 months per semester for students in V/VI/VII/VIII semester.
- c) Essential Repeat Restriction: Students with an "Essential Repeat" in any previous semester are not eligible for a No Objection Certificate (NOC) for internships.
- **d) Academic Requirements:** Students must have a minimum Semester Grade Point Average (SGPA) of 6.5 in all previous semesters.
- **e) Family Business Exclusion:** No attendance benefit will be granted for internships/apprenticeships in companies owned or operated by the student's parents or family.
- **f) Internal Assessment Responsibility:** Students will not receive any exemptions regarding internal or continuous assessments (other than attendance). It is the student's responsibility to submit all required assessments/tests during the internship period.
- **g) Special Cases:** Participation in official training programs/camps (e.g., NCC) for more than one month *may* be considered equivalent to an internship at the discretion of the principal of the institution upon submission of necessary documents.
- h) Summer/winter break internships: Students are encouraged to take up internships during summer/winter breaks. Such students are required to intimate the Placement and Career Development Cell about the same. If the internship period extends beyond the break, the students are required to obtain NOC from the college and may seek additional attendance benefit for the extended period, subject to the guidelines.

2. NO OBJECTION CERTIFICATE (NOC) APPLICATION PROCESS

Before beginning an internship or apprenticeship, students must obtain approval from the TIC and college administration by submitting the following documents to the Placement and Career Development Cell:

- Official offer letter from the host organization
- Marksheets from all previous semesters (or the latest available marksheet)
- Any additional documents required by the institution

3. DOCUMENTATION POST-INTERNSHIP/APPRENTICESHIP

Upon completion of the internship, students must submit the following within 15 days:

- Completion/Experience Letter: Issued by the host organization.
- Internship Report: Detailed report of the internship experience.
- Letter of Recommendation (Optional): Letter from the employer, if needed.
- Stipend Proof: If a stipend was received, either a bank statement or stipend slip must be provided.

Providing false information or documents will result in strict disciplinary action, including fines, suspension or expulsion etc., as determined by the Principal of the institution.

4. ATTENDANCE BENEFIT CATEGORIES

The following categories define the percentage of attendance benefits that students may receive based on the nature of their internship/apprenticeship.

Attendance benefit will be given only for the duration of the internship, subject to the guidelines.

Category A (100% Attendance Benefit):

- Publicly listed companies/organizations
- Public sector companies/organizations
- Big 4 audit firms or similar companies
- Big 3 consultancy firms or similar companies
- Vice-Chancellor's Internship
- Central or State government bodies and statutory/international organizations

Category B (80% Attendance Benefit):

- Work from office paid internships, with a stipend of Rs. 10,000/- or more per month for Management, Commerce, and Science students.
- Work from office paid internships, with a stipend of Rs. 8,000/- or more per month for **Arts** students.

Category C (60% Attendance Benefit):

• Work from office paid internships, with a stipend between Rs. 5,000/- and Rs. 10,000/- per month for **Management, Commerce, and Science** students.

Category D (40% Attendance Benefit):

- Work-from-home internships
- Start-ups not covered under Categories B or C

• Other organizations not covered under Categories B or C

5. SPECIAL INTERNSHIPS

a. Internships offered within the college

• PRCIS (Principal Ramanujan College Internship Scheme):

Students participating in paid internships at Ramanujan College will be granted attendance benefits in accordance with the ECA/Sports Attendance Guidelines. This benefit will be provided upon the recommendation of their assigned supervisor, based on the intern's performance.

(Refer to Annexure I for PRCIS guidelines)

• IAPC (Within College):

Students interning under IAPC within the college will be granted attendance benefits in accordance with the ECA/Sports Attendance Guidelines. This benefit will also be based on the intern's performance and supervisor's recommendation.

b. IAPC (Outside College):*

Students working outside the college under IAPC will receive attendance benefits according to Categories B, C, or D, depending on the host organization supervisor's report and intern's performance.

c. Articleship for Professional Courses:

Students in Semester V who have cleared the foundation level of professional courses such as CA/CS may apply for a NOC for Articleship. They may receive 60% additional attendance benefit, provided their SGPA is above 6.5 and all other conditions are met.

Note: Kindly refer to the University notification CNC-II/093/1(28)/2023-24/58, Dated: 31.08 for detailed IAPC guidelines

6. GENERAL CONSIDERATIONS

Attendance Calculation:

Additional attendance benefits will be calculated as a percentage of the total classes held during the internship period, following this document's guidelines.

• Discretionary Classification:

The **Placement and Career Development Cell** has the right to classify organizations into Categories **B**, **C**, and **D** based on:

o Industry norms

- The specific course
- o Internship profile of the student

Each case will be evaluated individually. Recommendations will be made to the Internal Assessment Committee.

Final decision lies with the Principal.

5.6 PANDIT DEENDAYAL UPADHYAY TRAVEL GRANT SCHEME

(For Participation in International Seminars, Conferences, and Symposiums)

1. INTRODUCTION

The Travel Grant Scheme is designed under Pandit Deendayal Upadhyay Research Development and Service Centre (PDURDSC) to support **invited faculty members** in making significant contributions to **national and international** seminars, conferences, and symposiums in India and abroad.

Objectives:

- Foster academic collaboration
- Provide opportunities for faculty to gain new insights
- Broaden research perspectives
- Advance and disseminate disciplinary knowledge

2. ELIGIBILITY CRITERIA

- 2.1 Applicant must be a **permanent faculty member** of Ramanujan College, University of Delhi, with:
- Significant research experience
- Demonstrable publication achievements
- Co-curricular activity records
- 2.2 Must have at least 3 publications indexed in Scopus or Web of Science.
- 2.3 Paper must be **accepted for oral presentation** by event organizers.
- 2.4 The applicant must be the **actual presenter**.
- 2.5 Paper must be in **English or Hindi**.
- 2.6 Faculty presenting as poster presenters or **rapporteurs** are **ineligible**.
- 2.7 Participation in workshops, trainings, refresher courses, etc., is not eligible.
- 2.8 Applications from Indian organizations hosting events abroad will not be considered.

3. SUBMISSION PROCESS

- 3.1 Applications are accepted **year-round** in 3 academic slots:
- January-April
- May–August
- September–December

- 3.2 Only two applications per academic slot recommended:
- One for India
- One for abroad
- 3.3 Minimum 3-year gap between two accepted applications. Max 3 times total during service.

- Invitation letter from event organizers
- **Abstract** of the paper
- 3.6 Within one month after the event, submit:
- Hard copy of full application

4. FINANCIAL ASSISTANCE, REIMBURSEMENT, AND CONDITIONS

- 4.1 Scheme provides **up to 50%** reimbursement of participation cost. Covered expenses:
- Economy class air travel or AC Second/Third Tier train travel
- Visa fees and travel insurance
- Registration fees (waivers encouraged)
- 4.2 Reimbursement Requirements:
- Detailed expenditure statement with receipts (airfare, visa, registration, insurance)
- Certificate of participation
- Original boarding passes
- An 800-word report on the seminar/conference/symposium, along with the full-length paper presented.
- **4.3** Faculty members are responsible for making their own travel arrangements, including:
- Booking economy class tickets only through authorized agents: Ashoka Travels and Tours, Balmer Lawrie & Company Ltd., or IRCTC.
- Visa and accommodation arrangements.
- **4.4** Incomplete applications will not be considered.
- **4.5** The college reserves the right to reject any application without providing a reason.
- **4.6** The final decision on the travel grant lies with the Principal of the college.

6. PLACEMENTS AND CAREER DEVELOPMENT INITIATIVES


This Cell provides career guidance and placement assistance to the students. It interacts with the industry and showcases the academic achievement of the students. It also focuses on enhancing the employable skills of the students through programmes on Personality Development, Interpersonal Communication, and Resume writing. It also invites leading industrialists and professionals, organises lectures, workshops, talks, seminars, and training programmes across disciplines.

Over the years, there has been impressive recruitment of students in various industrial sectors like Concentrix, Genpact, Data Flow, Naukri.Com, ICICI Prudential, Talocity, Tata Consultancy Services, Bajaj Finance, Ernst & Young. The efforts of the Placement Cell have also been fruitfully in placing the students with different lucrative summer internships.

With regard to the Career Development of our students, our placement cell has collaborated with many esteemed organisations to provide short-term courses with proper certifications open to all the students some of which include the Business Analyst course by Microsoft, Stock Market Models by BSE, etc. and classes for CAT preparation. The placement cell also organizes its flagship event "AARAMBH" the annual job and internship fair every year.

Departmentalization in the cell

The Placement Cell comprises five specialized departments: Research, Notice, Graphics, Data Management, and Outreach & Marketing. The Research Department builds corporate relationships, the Notice Department handles documentation, Graphics manages social media presence, Data Management maintains company and alumni data, and Outreach and marketing spreads awareness and manages events. These departments collaborate to provide holistic support for student career development.




6.1 INTERNSHIP OPPORTUNITIES


- The Placement Cell, led by experienced faculty and staff, coordinates both internships and placements throughout the year. They curate webinars, workshops, personality development sessions, and resume/interview training for students.
- A structured annual event called AARAMBH (e.g. AARAMBH 5.0 held on March 15, 2024) invites companies to offer both internship and placement opportunities on campus. In the 2023–24 edition, over 40 companies participated, offering 45+ internship profiles across roles like research analyst, AI evaluator, content writer, digital marketing, event coordinator, etc.
- Typically, companies like Zomato, Tech Mahindra, Genpact, Physicswallah, Chegg,
 DeltaX, and others participate, offering both in-person and remote internships.

Internship Statistics (2024–25)

- A total of 38 reputed companies participated in Aarambh 6.0, offering 77 unique profiles across internship and full-time placement opportunities.
- Of these, 28 companies offered full-time roles to final-year students, while 30 companies extended internship opportunities.
- Companies offered roles such as Financial Analyst, Research Analyst, Program
 Consultant, Operations Executive, Talent Acquisition Executive, Business
 Development Executive, Relationship Manager, Market Research Executive, among
 others.
- The highest package reaching 11 LPA.
