# ATTENDANCE REQUIREMENT FOR ISSUANCE OF ADMIT CARD TO SEMESTER V & III STUDENTS

### **FOR CURRENT SEMESTER III STUDENTS:**

For Students of semester III having attendance equal or above 40%:

a. Students with attendance equal or above 40% can collect admit card from the course dealing window after submitting an affidavit on Rs. 100/- stamp paper (format of the undertaking is attached with this notice).

For Students of semester III having attendance less than 40%:

- b. Students with attendance above 35% but less than 40% will be debarred from appearing in VAC paper in the December 2024 January 2025 semester examination. Such students can collect admit card after submitting an affidavit on Rs. 100/- stamp paper (format of the undertaking is attached with this notice).
- c. Students with attendance above or equal to 30% but less than 35% be debarred from appearing in AEC and VAC papers in the December 2024 January 2025 semester examination. Such students can collect admit card after submitting an affidavit on Rs. 100/stamp paper (format of the undertaking is attached with this notice).
- d. Students with attendance below 30% attendance will be altogether debarred from appearing in the December 2024 January 2025 semester examination.

### **FOR CURRENT SEMESTER V STUDENTS:**

Students of semester V are hereby informed that they can collect their admit card from their course dealing window by submitting an affidavit on Rs. 100/- stamp paper (format of the undertaking is attached with this notice).

Students who are getting admit card on the basis of undertaking on stamp paper need to meet at least an aggregate of 55% attendance requirement in third year i.e. semester V & VI for current semester V students and second year i.e. semester III & IV combined for current semester IV students.

The affidavit needs to be submitted by the parents in person with a valid ID proof.
