Such students can collect admit card after submitting an affidavit on Rs. 100/- stamp paper (format of the undertaking is attached with this notice).
- b. Students with attendance above or equal to 40% but less than 45% be debarred from appearing in AEC and VAC papers in the December 2024 January 2025 semester examination. Such students can collect admit card after submitting an affidavit on Rs. 100/- stamp paper (format of the undertaking is attached with this notice).
- c. Students with attendance below 40% attendance will be altogether debarred from appearing in the December 2024 January 2025 semester examination.

# Students who are getting admit card on the basis of undertaking on stamp paper need to meet at least an aggregate of 55% attendance requirement in first year i.e. semester I & II combined.
