**INSTRUCTION FOR CONTRIBUTORS**

The authors are required to provide research papers which are original, contribute significantly to the literature and solicit valuable implications for the business and industry. This journal follows a strict anti-plagiarism policy and discourages infringement of any type. When writing, keep the following in mind:

1. Differentiate between paraphrase or summary and directly-quoted material.
2. Do not copy and paste material directly from a source without citing it.
3. Memorable or key phrases must be reworded unless directly quoted.
4. Document or cite all lines of argument or reasoning.

**GUIDELINES FOR PAPER CONTRIBUTORS**

Original research articles are invited on the general themes in the discipline area of **Commerce and Management** from academicians, consultants, industry practitioners and research scholars. Abstract should be in about 400 words clearly mentioning the purpose, methodology, findings, limitations, implications and originality of the research article. The full research article should be in MS-Word with font Times New Roman, font size 12, 1.5 line spacing, and justified alignment. The article should preferably be of a recommended length of 15 pages in A4 size papers.

The title page of the article should include the details of the author viz., name, name of the organization, affiliation, e-mail address and the telephone number. All tables and figures should be numbered and should be aligned in the text with suitable captions. If the table/figure has been taken from a published source it should also bear the source from which it has been taken.

APA citation should be used to cite and create references. References should be placed at the end of the manuscript. The list should mention only those sources cited in the text of the manuscript. Authors are requested to follow APA (6 ed.) style developed by American Psychological Association.

**Book by two or more authors**

If there are more than seven authors, list the first six authors' names, followed by three ellipses, and then add the final author's name. See the example in the scholarly journal article section of this handout.

**Book by a corporate author**

A corporate author can be an association, a committee, or any group whose members are not identified individually. When the author and the publisher are the same, use the word *Author* as the name of the publisher.

American Psychological Association. (2010). *Publication manual of the American Psychological Association* (6th ed.). Washington, DC: Author.

**Chapter in a book**

Begin the citation with the information for the chapter you are using, followed by the information for the book. Notice the page numbers for the piece you are citing appear after the title of the book.

**Article from a reference book**

Begin the citation with the author for the entry you are citing. If no author is given, begin the citation with the title of the entry.
