



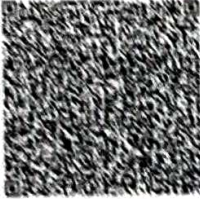

MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (MOU) is made on April, 10 2020 between Research Development and Services Cell (RDSC), Ramanujan College, University of Delhi located at Kalkaji, New Delhi – 110019 (Herein after called the 'First Party')

And

Teaching Learning Centre (TLC) of Ramanujan College, University of Delhi located at Kalkaji, New Delhi – 110019 (Herein after called the 'Second Party').

And whereas the *First Party* and the *Second Party* have agreed to the following terms and conditions of the agreement:

1. The aim of the hereby agreement is to enhance the capacity building of teachers/faculty members through organizing Online Faculty Development Programmes.
2. The Provisions provided by "First Party i. e Research Development and Services Cell (RDSC), Ramanujan College, University of Delhi located at Kalkaji, New Delhi – 110019 are given as under:-
 - a. Providing MOOC platform according to the type of programmes scheduled.
 - b. Providing technical support throughout the programme
 - c. Providing server support
 - d. Payment to Resource Persons
 - e. Payment to Administrative Staff
 - f. Overall Co-operation

3. The Provisions provided by "Second Party i. e. Teaching Learning Centre of Ramanujan College, University of Delhi located at Kalkaji, New Delhi – 110019 are given as under:-

- a. Administrative support in terms of organizers.
- b. Participation certificate
- c. Overall Cooperation

4. Name of both the coordinators and Principal/Director will appear.
5. Both the parties have agreed that they will extend every form of co-operation to each other.
6. The first party should ensure that the programme so conducted should be in adherence to the policies laid down by the MHRD and TLC, Ramanujan College from time to time. Such policies ensure the smooth conduct of any event.
7. The hereby agreement shall initially be conducted for Online FDP on **Managing Online Classes and Co-creating MOOCs during May 18 –June 3, 2020, however the agreement can be extended to organize more such FDPs in future.** Both the parties will be responsible for organizing and managing the FDP/Faculty Induction Program/Workshops/Seminars/Conference as per the provisions mentioned above.

9. Following rules will be applicable for the funds accrued:

If the estimated expense is less than the real expense incurred, the amount left will be part of Ramanujan College.

If the estimated expense is more than the real expense incurred, then that will be borne by RDSC, Ramanujan College.
